Bus Policy for Preschool Students (Age 4-5 Years Old)

***Children under 4 years of age** cannot ride the school bus to school unless they are in Early Childhood Special Education.

***Once a child turns 4 during the school year**, they are then eligible for bus transportation if appropriate paperwork is completed and submitted to the EC Coordinator and the Bus Company (and if the home location is on a current bus route: TBD by the Bus Company).

Kimball Area Early Childhood Education programs provide transportation to and from school for students enrolled in our Preschool program and are a minimum of 4 years of age. Students who qualify for services through Early Childhood Special Education (ECSE) will be transported per state law.

Bus transportation MAY be an option at 8 AM and 3PM for **4 and 5 year old preschoolers**, if there is an **existing stop** at the home AND there is available space on the bus. Mid-day busing is **ONLY** available to those students who qualify for special education services. ALL preschool students (**except special education students**) younger than 4 years old need parent transportation to and from school.

Parent-Bus partnership is important for the safety of students. Please visit with your preschooler on a regular basis regarding expected bus behavior including: sitting at the front of the bus, staying seated at all times (except when entering and exiting the bus,) and using quiet voices. If behaviors become a distraction or a safety concern on the bus you will be asked to provide your own transportation for your child to and from school.
